Functions of the SEDGs Cell:

- 1. To ensure equitable access and participation of students and staff from socioeconomically disadvantaged groups in all academic and administrative processes.
- 2. To identify and support SEDG students through bridge courses, remedial classes, mentorship, and counselling.
- 3. To facilitate access to scholarships, fellowships, and government welfare schemes.
- 4. To monitor implementation of UGC and Government policies on inclusion, reservation, and welfare for disadvantaged groups.
- 5. To organize sensitization and awareness programmes promoting equity, diversity, and inclusion on campus.
- To address grievances and ensure non-discrimination based on social, economic, or community background.
- 7. To **submit annual reports** on the activities and progress of the Cell to the University authorities and the UGC.

This Cell shall function under the supervision of the Chairperson and report periodically to the University administration on activities, progress, and outcomes related to equity and inclusion.
